## **Statement**

of reading the clause regarding the processing of personal data and on informing about its content persons whose personal data are provided to the Ordering Party in the content of the offer to

perform the contract being the subject of the inquiry no 22/2023 carried out as part of the project: Automation, robotization and digitization of cable harness production processes at Aptiv Services Poland Spółka Akcyjna in order to increase the company's production capacity and increase the reliability of the final product,

implemented as part National Recovery and Resilence Plan (KPO), Component A "Resilence and Competitivness of the economy", Investment: A 2.1.1. Investments supporting robotization and digitalization in enterprises.

I have been informed that the administrator of my personal data and/or documents will be the Company and that my personal data and/or documents will be collected and processed in order to conduct the tender procedure no. 22/2023 in accordance with the principle of competition, in accordance with art. 6 points 1 a, b, f GDPR (i.e. Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/EC (General Data Protection Regulation).
