implemented as part National Recovery and Resilence Plan (KPO), Component A "Resilence and Competitivness of the economy", Investment: A 2.1.1. Investments supporting robotization and digitalization in enterprises.

I have been informed that the administrator of my personal data and/or documents will be the Company and that my personal data and/or documents will be collected and processed in order to conduct the tender procedure no. 8/2023 in accordance with the principle of competition, in accordance with art. 6 points 1 a, b, f GDPR (i.e. Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/EC (General Data Protection Regulation).
